You must be set-up and have all vehicles/trailers off the grounds **1 hour before the fair opens. You must remain open ALL hours fair is open.**

Your completed application must be received by **5:00 p.m. on Monday, March 19, 2012.** Space is limited, so get your application in early! Applications received after **March 19, 2012** must include a late fee as listed above.

Indemnification and Agreement

The Vendor agrees to accept full responsibility for the quality of any and all goods sold by the vendor and the vendor's organization at the 2012 Lacey Spring Fun Fair. **Vendor agrees to be open during all fair hours on both days of fair.**
